The following question refers to your opinion as to the future of the Japanese pension system. On February 23, 2009, the Health, Labour and Welfare Ministry released an estimate stating that by 2038 benefits paid through employee pensions (the "benefit level") would be equivalent to 50.1% of after-tax income for those currently in work. (In 2009, the benefit level was 62.3%)

However, this level is calculated using a basic scenario which assumes the following conditions, among others: total fertility rate: 1.26; wage growth rate: 2.5%; rate of return on deposits: 4.1%.

If the conditions are set to the most pessimistic values, the benefit level would be 43.1% in 2048. For the most optimistic values, the benefit level would be 54.6% in 2032.
